FIRE DEPARTMENT BUSINESS

Received the Fireman's April, 2015 - Maintenance Reports/Treasurer's Report

Fire Chief Updates

- 1. There is a leak in the roof in the fire hall. R. Fountaine will notify the maintenance man.
- 2. The fire department has received the 2% grant which will be used for air bag.

WATER SYSTEM BUSINESS

- a. April, 2015 water system report was received.
- b. Resident Requesting to Move Water Service Mark suggested that a totally new line be put in going straight across to the main. A splice should not be used. The main is on the other side of the highway. This would be at the customer's expense. The \$600.00 mentioned in the letter is now owed to the County and not the Township. Therefore, any monies need to be paid directly to the County.
- c. A Special Water System Meeting will be scheduled for June 6, 2015 at 3:00 p.m.

Moved, R. Fountaine, seconded, G. Boudreau, CARRIED, to accept the water report.

UNFINISHED BUSINESS AND UPDATES

- a. Repair of Fence near Pavilion Defendant did not show up at Small Claims Court. A default judgement was received by the Township. The claim was filed with the Township's insurance company and the check has been received for \$499.94 which is the total bill less the deductible of \$500.00. Delta Fence will be scheduling the repair. R. Fountaine will have the maintenance man look into temporarily repairing the fence.
- b. Equalization Agreement There has been no further progress.
- c. Trimmer for Cemetery M. Krause got two quotes. It was decided to go with the trimmer available at Northgate.
- Moved, G. Boudreau, seconded, P. Anderson, CARRIED, to purchase the trimmer from Northgate Equipment in the amount of \$210.00.
 - d. MSUE Trainings There is a charge for one of the meetings, Leadership through Effective Meetings which is \$40.00 per person.

Moved, R. Fountaine, seconded, A. Wagner, CARRIED, to allow three people to attend the Leadership through Effective Meetings at the cost of \$40.00 per person. If R. Fountaine is able to go, there would be a fourth person.

NEW BUSINESS

Moved G. Boudreau, seconded, A. Wagner, CARRIED, to pay bills from the General Fund in the amount of \$15,614.91 and the Water Fund in the amount of \$1,915.17. The bills for Cooper Office Equipment will be further looked into.

- a. Ice Cream Social R. Fountaine asked if the Fire Department might want to take this over as a fundraiser for the Volunteer Fire Department. A possible date would be 9/13/2015. Jon will check with the members of the fire department regarding this.
- b. The Township attorney, John Bergman, has passed away. R. Fountaine talked to his son, who is taking over his father's cases. He does do Township Law. R. Fountaine felt that the Township should stay with J. Bergman, Jr. as his law office has all the Township records at least on a short term basis.
- c. Pest Control R. Fountaine suggested that the Township have Penoza Pest Control spray the well house, pavilion and Township Hall, Fire Hall and sheds at both cemeteries.

Moved, R. Fountaine, seconded, A. Wagner, CARRIED, to allow Penoza Pest Control to spray the well house, pavilion, Township Hall, fire hall and sheds at both cemeteries provided the cost is less than \$1000.00.

d. Landscaping – R. Fountaine provided an estimate that she requested from Bittner Excavating to top dress with washed stone on both sides of firehall under eaves and apply topsoil between fire hydrant and parking lot at township hall, installing 15 cyds topsoil, rake, seed, fertilize and mulch. The estimated cost is \$625.00.

Moved, G. Boudreau, seconded, A. Wagner, CARRIED, to hire Bittner Engineering to bring in top soil and stone to fix areas at the pavilion and fire hall.
