Ford River Township Planning Commission Regular Meeting minutes Meeting date July 10, 2014

The meeting was called to order at 7:00 p.m. by Chairman Nelson Present were: Mr. Ciminskie, Mr. Wellman, Mr. Lippens, Mr. Tryan.

Also in attendance: Six citizens and Supervisor Fountaine

<u>Public Hearing</u> – Tom Buchholtz – Special Use Permit for an accessory building 60" x 100' Hearing opened at 7:03.

A question was asked if all neighbors were notified – Yes. Comment was made that property owners across the river may be in the notification zone but were not notified.

Were there any responses? Yes 2. One in favor of the permit, and a second with concerns about the private road. The private road has existed since at least the 1960's. This road would be grandfathered since it existed before the ordinance. There is no change of property ownership in this case so the new private road language in the ordinance would not apply.

One of the neighbors commented that they were strongly in favor of the permit since it would benefit everyone on the road because the equipment used to maintain the road would be stored in the new building. Maintaining the road is beneficial for emergency services as well as access by the residents.

The Planning Commission suggested that the best action is for the users of the private road to form a Homeowners Association to deal with road issues.

Section 604 General Standards were reviewed and all were approved.

A motion was made by Mr. Tryan, seconded by Mr. Lippens to Grant the Special Use Permit with the condition that the building was to be used for storage only and no commercial activity. Unanimous approval.
